



BOSJES, nestled in the Breede Valley between the Witzenberg and Slanghoek mountain ranges, is surrounded by nature and offers some of the most stunning landscapes for a South African wedding or elopement.

CEREMONY

The wedding ceremony takes place in our magnificent Kapel. With carefully landscaped gardens, it also offers the perfect background for your photo shoot.

RECEPTION

Bosjes Kombuis boasts high ceilings and glass walls, giving it a light and airy feel. Our maximum capacity for weddings at Bosjes is 100 guests. The deck area, with a breathtaking view of the game camp and mountains, is reserved for pre-reception drinks and snacks.

ACCOMMODATION

Die Herehuis (Manor House) will be your home during your stay. Three double rooms with breakfast for 6 guests are included in the package. The remainder of the rooms will be reserved for guests attending your celebration but is not included in the package rate. Herehuis can accommodate a total of 14 guests sharing.

We can assist with a list of alternative accommodation options in the area for the overflow of guests.

RATES

R80 000 (March 2023 – Feb 2024)

Included:

- Three double rooms in Herehuis Friday & Saturday night
- Use of the Kapel for ceremony
- Use of gardens for photo shoot
- Use of Bosjes Kombuis for reception and pre-dinner drinks and snacks

- White crockery, silver cutlery, glassware (wine glass and champagne flute)
- Coffee and tea service during dessert
- Two on-site meetings with the venue manager
- One barman, six waiters and one floor manager (for 60 guests)

M E N U

- Regrettably, Bosjes does not offer menu tastings
- The menu options are set and may not be changed or altered
- Bosjes does not allow outside catering
- The final confirmed menu is required 40 days prior to the wedding date
- Any extras will be charged for on the day
- Bosjes is neither Kosher nor Halaal certified
- Pre-dinner canapés are only served at Bosjes Kombuis

Please note, situations such as extended speeches, additional speeches or unexpected changes in the order of events will affect the efficiency of the kitchen considerably and may affect the quality of the experience. Our team will be using the agreed order of events as a guideline to the timing of their operations. The order of events/function sheet is required 14 days prior to the wedding along with the table layout, seating chart and guestlist.

B A R A N D B E V E R A G E S

- Bar service and venue hire ends at midnight
- Venue hire can be extended until 01:00 latest at a charge of R3000 per hour or part thereof (to be arranged and paid in advance). Bar service will still end at midnight.

Bosjes Kombuis is fully licensed and supplies all beverages exclusively. A cash bar service is available at a fee of R2000. This fee is waived if you wish to have an open bar. Open bar services are to be arranged in advance.

Should you wish to rather employ a company to supply the pre-dinner drinks, a corkage fee of R15pp is applicable, calculated on the total number of guests. The company supplying the pre-dinner drinks should supply their own bar, glassware, staff and garnish. This is only allowed during pre-dinner and not during reception.

Corkage on wine or MCC supplied by the client is charged at R40 per bottle or part thereof.

No drinks may be served at Kapel other than bottled water (glass). Pre-dinner drinks are only allowed to be served at Kombuis.

M U S I C & S O U N D

- Due to local noise regulations, music ends at 00:00 sharp (01:00 when overtime is booked)
- Bosjes reserves the right to regulate the volume of the music at any event held on its premises
- The DJ employed must be registered with SAMRO/SAMPRA and have his certification on hand

SUPPLIERS & HIRED GOODS

- Bosjes does not include the services of a planner/coordinator on the day. We highly recommend that you make use of this professional service from the list of suppliers provided
- All hired goods will be the responsibility of the client or their appointed planner/coordinator. Bosjes will not be held responsible for any damages or late returns of hired goods.
- All equipment, hired goods, décor and flowers brought onto Bosjes farm may be delivered the day prior to the wedding date from 17:00-19:00 and must be collected by the client/their employed suppliers or planner between 07:30-09:00 the morning following the wedding date. Setup on the day of the wedding may commence from 07:30. All hired goods must be removed from Kapel & Kombuis before 09h00 the day following the wedding.
- Bosjes Kombuis & Kapel operates on the day before and after your wedding date. No abstractions may occur. If not adhered to, management will dispose of any items as they see adequate. Arising costs thereof will be carried by the client
- Décor and flowers must be arranged by the client and is for their own account. The client will be held liable for any indemnities that may occur due to the negligence of their employed suppliers
- Bosjes has certain décor restrictions due to architectural and structural reasons. Please check with the venue manager before planning your décor. Final approval of all hired goods will be made by the management of Bosjes
- Only natural and eco-friendly confetti products are allowed
- No polystyrene products are allowed on the premises

ACCOMMODATION

- Guesthouse rooms may not exceed its capacity
- Breakfast for 6 guests only is included. Should the client not make use of the breakfast option, the value of the inclusive breakfast will not be refunded or allocated to another service and or items
- Friday night dinner is excluded but can be arranged at an additional cost
- Bosjes caters exclusively for the guesthouse. No food may be brought onto the premises
- Check-in from 14:00; Check-out before 10:30

TERMS AND CONDITIONS

- All rates are subject to change without prior notice
- All rates exclude beverage prices, which will be based on consumption
- All rates exclude menu prices, which will be based on the choices provided
- A service charge of 15% will be added to the food bill, beverage bill and final account
- Other departments on Bosjes will be operating on the day of your wedding

DEPOSITS AND CANCELLATIONS

- 50% deposit of the venue hire is required within 7 days of making the booking in order to secure the reservation at Bosjes
- The second half of the venue hire fee will be due 30 days prior to the wedding date
- Full payment of the total food and beverage account is required 30 days prior to the wedding date
- Full payment of the final account must be settled before checkout the day after the wedding date
- No meal refunds will be made 21 days prior to the date should the guests decrease in numbers, nor will the value of the cancelled items/services be allocated to another service/items
- A R10 000 refundable breakage deposit will be required in advance in case of any shortages, damages and or loss to any property of Bosjes
- Bosjes does not offer account facilities or payment plans

- Cancellation of the date 1 – 4 months prior to the wedding date will result in a loss of the 50% deposit
- Cancellation of the date within 1 month of the wedding date will result in a 100% loss of total amount agreed upon
- Once the wedding date has been secured, the date may not be postponed
- Bosjes reserves the right to cancel all services should full payment not be received one month prior to the wedding date
